There occured no changes after the communication of the rating to the rating object.

Rating Summary:

Creditreform Rating has confirmed the unsolicited bank rating of Bank of New York Mellon Corporation with A. The outlook is stable from watch negative. The rating is based on the stable business with steady net profits in the recent years and the high quality of assets. On the other hand, the Bank of New York Mellon Corporation has only average equity figures and a high cost income ratio compared to the peers. The Bank of New York Mellon Corporation is a worldwide investment company with a good market position in investment services and investment management.

Rating Scenarios:

Please note: The scenarios are based on information available at the time of the rating. Within the forecast horizon, circumstances may occur that could lead to a change of the rating out of the indicated range.

In a scenario analysis, the bank is able to reach an "A+" rating in the "best case" scenario and an "BBB+" rating in the "worst case" scenario. The ratings of bank capital and senior unsecured debt would behave similarly based on our rating mechanism. These ratings are especially sensitive to changes in total equity and to the bank capital and debt structure in general.

Best-case scenario: A+

We could upgrade BNYM's long-term issuer credit rating and its bank capital and debt instruments if we see BNYM continuing to outperforming its peers in regards to the COVID-19 crisis. In addition, a continuous improvement of the bank's capital ratios and an increase in asset quality might lead to an upgrade as well.

Worst-case scenario: BBB+

By contrast, a downgrade of BNYM's long-term issuer credit rating and its bank capital and debt instruments is likely if we see that BNYM fares significantly worse due to the COVID-19 crisis. A spike in risk-weighted Assets and deteriorating asset quality in general, a decrease in profitability due to significantly higher costs of risk over the medium term and a decline in business activity would likely lead to a downgrade of the rating.

Corporate Governance is identified as a highly significant rating driver. The relevance for the credit rating results from the impact of the Corporate Governance factor on all other ESG factors and the overall well-being of the bank. This sub-factor is rated positive due to BNYM's strong and sustainable earning figures, the widespread ESG policies and its ambitious ESG targets.

Corporate Behaviour and Green Financing / Promoting are identified as moderate rating driver. While Green Financing / Promoting is rated positive due to relatively high amount of green bonds, Coporate Behaviour is rated positive due the ethics principles.

To prepare this credit rating, CRA has used following substantially material sources:

- 4. Website of the rated bank
- 5. Public and internal market analyses
- 6. Internet research

There are no other attributes and limitations of the credit rating or rating outlook other than displayed on the CRA website. Furthermore CRA considers satisfactory the quality and extent of information available on the rated entity. In regard to the rated entity Creditreform Rating AG regarded available historical data as sufficient.

Between the disclosure of the credit rating to the rated entity and the public disclosure no amendments were made to the credit rating.

The "Basic data" information card indicates the principal methodology or version of methodology that was used in determining the rating, with a reference to its comprehensive description.
